

Civic Research Institute Online Subscription Terms of Use

Institutional Subscriptions

When you send us an order to begin an institutional subscription in print-and-online, you agree to the following terms of use—

- Your subscription is for your institution's use only. IP addresses you provide must be for users located within your zip code; IP addresses for locations outside your zip code may not be included in a single institutional subscription. You may not photocopy, email, or otherwise reproduce or distribute articles or issues or share them with anyone outside your facility—unless you pay for the right to do so through the Copyright Clearance Center. You may circulate your print copy with a routing slip to as many people as you wish (and we encourage you to do so) but you may not photocopy the print version to circulate, or as a backup copy. For examples of permitted and prohibited uses, see our FAQs on the next page.
- 2. You may **download and print or save** articles or complete issues as needed by your users **as long as you maintain an active subscription**. You may **not** keep **permanent copies** of articles or issues on your computer or on any storage device, except for articles or issues cover dated during the term of your subscription. You may download articles or issues published before your subscription term began, but you must **delete these completely** after use. You are not required to delete articles or issues published during your term as an active paid subscriber. If you are not sure about your subscription terms, we can tell you.
- 3. You may allow **access to your subscription from any internet-connected device** you recognize as an authorized user—employees and staff, students and faculty, and inperson visitors using your facilities. If you permit access to authorized users from remote locations via proxy server, you may include access to your Civic Research Institute subscriptions as part of that service.
- 4. You may **not share access with other branches, satellite offices, or other locations** located outside your zip code. Branches, satellite offices, and other divisions or departments must have their own subscriptions.
- 5. Cancellations. You may cancel your subscription at any time, but we do not issue refunds for the "unexpired" term of online subscriptions (as we do with print subscriptions). If you ask us cancel an online subscription before its expiration date, we will "cancel at expiration" and continue your online access until the end of your term.



Frequently Asked Questions

Q-1: Our facility is part of a large system. May we share access to our subscription with other branches or departments in the system? **A:** No. If the department, satellite, or branch is located in a zip code different from yours, you may not share access to your Civic Research Institute subscriptions. Such locations must have their own subscriptions.

Q-2: We maintain an in-house "intranet" we use to communicate among staff. May I post an article from my subscription to our in-house intranet? **A**: You may temporarily post articles on an in-house intranet or similar network, but only if access is limited to personnel within your facility. If you discontinue your subscription, all such posted materials must be deleted.

Q-3: We circulate a "current contents" alert to our users. May we include links to articles in our subscription in these contents alerts? **A**: Yes, as long as the links go to our website, not to a copy archived on your servers.

Q-4: **May we circulate articles or issues via ILL? A**: No. Every article and issue in your subscription is also available to non-subscribers via pay-per-article. Direct requests for articles to our subscriber services department: 609-683-4450.

Q-5: If we discontinue the subscription, will we still have access to online content published during our subscription period? **A**: No. Your online access is deactivated when your subscription ends. We offer print-and-online as our basic default option, which means you will always have the print copies of issues published during your active subscription period. We will replace any print issue missing from your collection at no charge. (If we have to replace that same issue a second time, however, you will be charged \$25.)
