About ICCA

ICCA incorporated in 1964 as the International Halfway House Association. In its early years, membership was primarily halfway house provider agencies and governmental agencies that funded halfway houses. In 1989, the association changed its name to reflect important changes in community corrections and the broader diversity of community-based programs.

In 1993, ICCA initiated its first research conference under the name "What Works". In the decade since then, ICCA's applied research forums have become an important source of innovative thinking as well as quantitative data agencies can use to set policy and spending priorities. ICCA's focus includes the traditional probation and parole missions of supervision and monitoring, but places an even stronger focus on evidence-based treatment in both institutional and community settings. Today, ICCA members include the full spectrum of treatment-based organizations including jails, juvenile detention, community-based drug and substance abuse offender treatment, and of course, halfway houses and probation and parole agencies.
